

# Water & Wastewater Utility Rates ~ 2019

## Consumption & Fixed Charges

Billing for water and wastewater services is generally based on three factors: 1) fixed quarterly service charges based on the water meter size; 2) flow or volume charges reflecting the consumption recorded by the meter; and 3) public fire protection based on improvement value of the property.

The rate structure for Public Fire Protection charges is based on the assessed value of the improvements on a parcel of land and not on the property's total assessed valuation. This charge is for the ability to deliver a large quantity of water quickly to the location of a fire. It includes the cost of water pumping, reservoirs, mains and fire hydrants. The value of the improvements on your property can be determined by reviewing the most recent property tax bill.
