

The Janesville Recreation Division offers scholarships for income eligible children applying for Kids Count Camp (full day or half day option). Please refer to the Eligibility Requirements for additional information.

Individual scholarships will be awarded for the entire cost of the camp session, including field trip. Applications will be accepted through Friday, May 18, or until all available scholarships have been awarded. Applications will be processed on a first come basis until scholarships are depleted. Please refer to the City of Janesville Spring/Summer Parks and Recreation Guide for a variety of program options.

#### Eligibility Requirements

1. Youth and their families **must reside in the City of Janesville.**
2. Our program is designed for children that are 5-12 years old.
3. Students and their families must qualify as low/moderate income, based upon the chart below.

## NEED MORE INFORMATION?

### Which Summer Camp Programs are eligible for the Scholarship Program?

The Summer Camp programs with a Scholarship logo next to them in the 2018 Spring/Summer Parks and Recreation Guide are eligible for scholarships.

Janesville Recreation Division will offer 3 scholarships per session of Kids Count Camp, and 3 scholarships per session of KCC 1/2 Day Camp.

### When are applications due?

Scholarships are awarded on a first-come, first-served basis until the designated number of scholarships are gone. You are encouraged to apply as soon as possible. Applications will be accepted through Friday, May 18, or until all available scholarships have been awarded.

### How many scholarships can my child receive?

A child may receive one scholarship for one session of Kids Count Camp (KCC) or two 1-week sessions of KCC 1/2 Day Camp.

### How will I find out if my child received a scholarship?

You will be notified by mail if your child received a scholarship and the camp session (s) awarded. Camps require that your child bring a lunch each day. Lunch is not included in the scholarship.
